TEMPORARY EVENT SIGN PERMIT APPLICATION

A temporary event sign is defined as any temporary sign that highlights or advertises an upcoming event, including festivals, elections and/or candidates, and similar occasions.

The Development Code provides several general provisions with which each individual associated with the event must comply:

- (I) Such temporary signs shall not be posted more than 30 days before an event. All such signs shall be removed within 7 days after the same event. Such temporary signs posted on vacant property must have written consent of the property owner.
- (II) Such temporary signs shall not be erected within any street, intersection, clear sight triangle, or at any location where the sign may interfere with, obstruct the view of, or be confused with any authorized traffic sign.
- (III) Such temporary signs shall not be nailed or affixed to any tree, fence post, or public utility pole and shall not be located in the public right-of-way, parkway, or on publicly leased property.
- (IV) Such temporary signs require a permit prior to the placement of temporary event signs within nonresidential sites. Said permit shall be issued at no cost to the applicant. It shall be issued to the applicant upon their signature indicating their agreement to be bound by the provisions of the City's Temporary Sign Ordinance.
- (V) Such temporary signs are subject to the regulations defined by Section 87.0735 of the Development Code.

If at any time a sign is deemed in violation of the City Code, the sign shall be removed, and the permit holder may be assessed a fine of the following:
